**Payment Options:**

- Annual payments due July 1, 2012.
- Semi annual payments due July 1, 2012 and December 1, 2012.
- Monthly installment plan available via FACTS Tuition Management with an annual service fee of \$41.

**New Families:** upon acceptance of your student(s), please go to the [www.daytonchristian.com](http://www.daytonchristian.com) website and click on the link entitled – “*FACTS Payers Online Account Setup*” to register online for your FACTS payment user account.

**Re-enrolling families** with existing FACTS payment accounts will be notified by FACTS Management Co. in June, 2012 of when FACTS will be debiting your account for the annual \$41 service fee.

**DELINQUENT ACCOUNTS PROCEDURE:**

***Prompt payment of your tuition account ensures that we can pay our teachers and bills on time. The following procedure has been established to encourage our families to stay current with their payments. If at any time you experience difficulty paying your tuition, please contact the DCSS Finance Office at (937) 291-7560 for help before the account is past due.***

1. For FACTS monthly payments:
  - If a FACTS payment has been missed, a notice will be sent by FACTS.
  - **Please note, that according to your FACTS payment agreement, a \$30.00 fee will be assessed by FACTS the first time a payment is rejected. (For example, due to Insufficient Funds or Stop Payments, etc.).**
2. For annual and semi-annual payment options:
  - If your account is 30 calendar days past due, an additional **\$50.00 late fee** will be assessed to your account by DCSS, and for every additional 30 day period past due.
3. **Please note:** For all payment options, if payment isn't made by the end of 30 calendar days, **your child will be withheld from classes** until the past due balance is paid.
4. **Please note:** ANY CHECKS WRITTEN TO DCSS FOR ANY EVENT, ACTIVITY OR FEE THAT ARE RETURNED DUE TO INSUFFICIENT FUNDS WILL RESULT IN A \$25 RETURNED-CHECK CHARGE.

**7<sup>TH</sup>- 12<sup>TH</sup> GRADE ATHLETIC/DRAMA PARTICIPATION FEES:**

The 7<sup>th</sup> – 12<sup>th</sup> grade athletic/drama participation fees are **\$125** per student per activity, **with no family cap**. The participation fees will automatically be added to your tuition account upon receipt of the rosters in the Finance Office. If you are paying via FACTS, **the fee will be added to your FACTS Agreement**. For further information, you may call (937) 291-7560.

**TUITION ASSISTANCE:**

Any financially responsible family who is unable to afford tuition at DCSS may apply for Tuition Assistance. Tuition Assistance is awarded on a needs basis. **We use FACTS Grant & Aid Assessment Company as our income verification service. You may file an application online at [www.factstuitionaid.com](http://www.factstuitionaid.com) for a fee of \$25. DCSS Tuition Assistance instructions and a required church evaluation form are available online at [daytonchristian.com](http://daytonchristian.com) on the Tuition Assistance page. For further information, you may call the Admissions Office at (937) 291-7215.**

**1. If you are a returning-student family applying for Tuition Assistance, to be considered for aid, your Tuition Assistance application MUST be submitted to FACTS Management Company by **March 30, 2012, AND** your re-registration materials must be submitted via online re-enrollment by **March 30, 2012.** (Your re-registration materials may be submitted separately to the DCSS Admissions Office in order to meet the Early Registration Incentive deadline of March 5, 2012.) **You must be current on your 2011-12 tuition payments to be considered for tuition assistance.****

**2. For new student families applying for Tuition Assistance,** the Tuition Assistance application will need to be submitted to FACTS Management Company no later than 2 weeks after your child(ren) are officially enrolled/accepted at DCSS.
