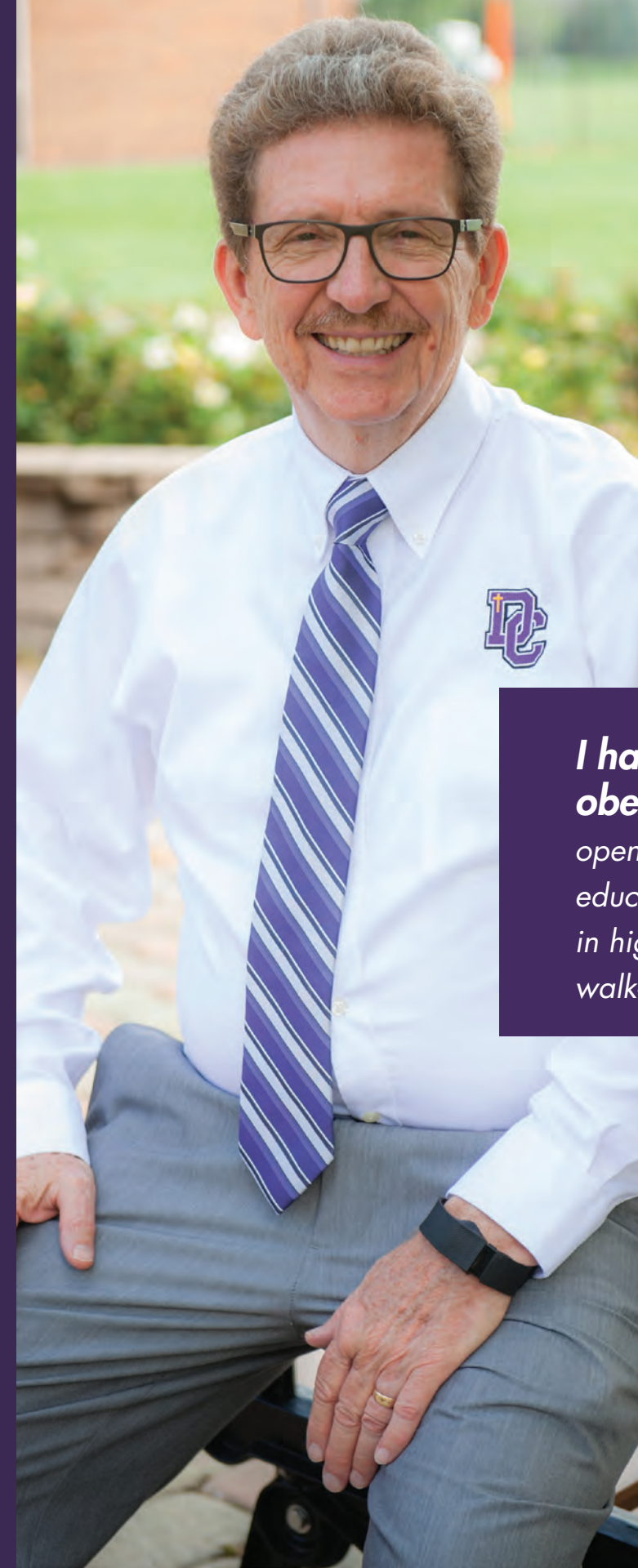



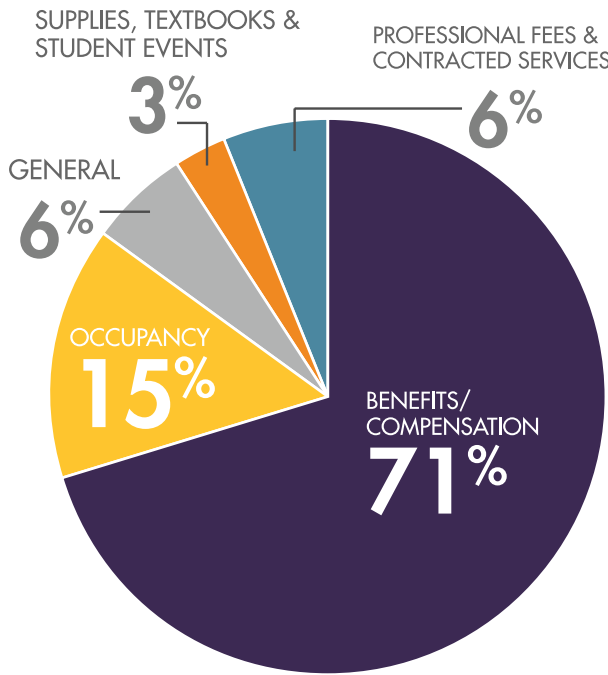
The Rulane Legacy Academic Scholarship and Extracurricular Grant

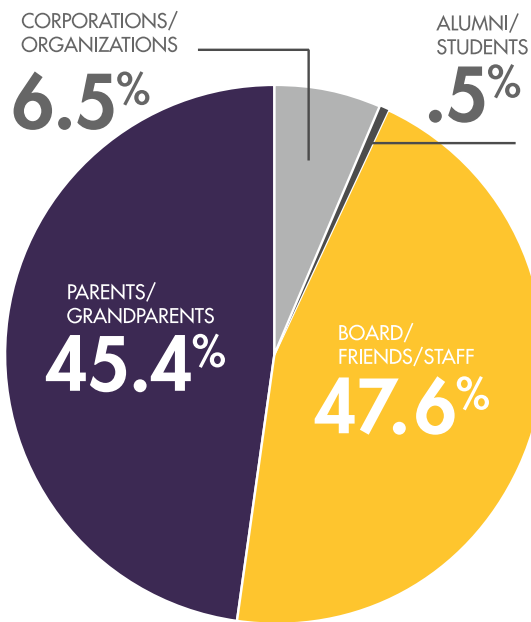

METHODS

IMMEDIATE

Give Now: Make an immediate impact with a secure gift via credit/debit card on our Support Us page, or by mailing a check to Dayton Christian School **“Attention Advancement Office”** 9391 Washington Church Road, Miamisburg, OH 45342. All contributions are acknowledged and receipted for tax deduction purposes. Please visit our website for ways you can support the ministry at daytonchristian.com/support-us.

Recurring Gifts: We can make your repeat contributions easier with an automated transaction. Simply choose “Make My Gift Recurring” when entering your information on our donation site.

Tribute Gifts: Enable gifts to Dayton Christian to be made in celebration of someone’s major event such as their graduation, baptism, or wedding. Or, honor a family member or friend upon their passing, and be notified when a gift is made in their name.

Corporate Matching Gifts: Many employers sponsor matching gift programs and will match charitable contributions or volunteer hours made by their employees (sometimes even from their spouses and retirees). To find out if your company has a matching gift policy, please visit our Support Us page and enter your employer’s name. If your company is eligible, request a matching gift form from them. If you don’t see your employer listed, contact your HR office to see if they would consider matching your gift.

Gifts In Kind: Dayton Christian benefits greatly from donated items which we could or would not be able to purchase from our limited operating funds. There

can also be deduction advantages for contributing items based on fair market value. Please contact the Advancement Office to see how particular gifts in kind can help move the needle.
